Food Management at CSM	<b>09/14/2016</b> - Concern was brought forward regarding the need to address food allergies in the school classrooms and the need for due diligence to protect students in every possible way to avoid harm, and even death in some cases where allergies are very serious. During classroom activities and special celebrations (i.e. Christmas, birthdays, Halloween, etc.) parents are encouraged to AVOID bringing in any home baked goods as the risk of contamination with nuts, etc. is much greater. Teachers will also continue to be vigilant in ensuring they understand and manage the food being brought into their classroom and shared. School Supplies Fee	<b>09/14/2016</b> - Approximately 70% of the funds have been collected for student supplies fees. Emails and notes will be going home to the remaining 30% not yet paid as a reminder to send in your fees.
