Attention: Derek O'Brien

I am writing on behalf of the Blacks Harbour School P.S.S.C as Chair and BHS Home and School Committee as the current President. As a committee we would like to express our concern with the new nutritional policy 711 that was put in effect for the new 2018-19 school year. The policy states (taken from the GNB website) "All foods and beverages sold, served or otherwise offered in all NB public schools require foods of higher nutritional value which are lower in saturated fat, sugar, or sodium. Includes breakfast programs, lunch, hot lunch programs, vending machines, a la carte items, canteen snacks and *FUNDRAISERS*. Also includes items that are not for sale, such as foods and beverages offered to students during classroom or school wide events."

We would like to express our frustrations not with the policy itself, but with the fact that a lot of other schools all over NB are **NOT** following these guidelines. They are continuing to offer items during school events or fundraisers that do not meet the Policy 711 guidelines. Fundraisers put on by our home and school, as with many schools, help raise money to fund field trips, events, classroom extras, breakfast and lunch programs, new and updated technology, playground equipment and the list goes on. Our school, in a small community, relies on home and school funds to help in these areas that the school budget does not cover during the school year. This year, due to the new policy, we have lost out on one of our biggest fundraisers, our annual Trunk or Treat. Our home and school members have worked hard to come up with events and fundraisers for the new year that stick with the Policy 711 guidelines, but our neighboring schools are still having events and fundraisers which the policy restricts including the serving or sale of candy, hot dogs, pop & chips, baked goods etc.

We would like to request your presence at a meeting to discuss this new policy. We ask that you clarify the guidelines and explain why our school is not allowed while so many others are. We are interested in knowing how this policy is being enforced, and whose job it is to make sure the policy and its guidelines are being met. We would also like to know what the consequences are for not keeping with the policy, and if committees like the home and school are able to keep fundraising. Parents, community members and staff have questions that need to be addressed and have answered.

Thank you for taking the time to review my letter and request and hope that we can meet and discuss this matter further.

APPENDIX B

Response from Derek O'Brian:

Called to inform us that he received the H&S/P.S.S.C letter we had sent and to tell us that yes Policy 711 is indeed in effect and being enforced by the school district. No changes have been made to the guidelines released in the fall. Policy 711 has yet to be revised at the current time. It is to be followed by every school in ASD-S. He thanked us for voicing our concerns and frustrations and making him aware of some events going on that did not meet the new guidelines. He said they need to be brought to his or Zoe Watson's attention. He acknowledged that he understands how frustrating it is on our H&S and PSSC that we are following the guidelines and other schools are not. It is the job of the schools principals to monitor group events and making sure they are following the rules, and if not to make sure the event/fundraiser is shut down. He said that they were doing their best to try to get to the events before hand and to put a stop to them but they cant monitor every school closely and they are relying on the principals/staff, who were made aware of the policy and guidelines, to make sure they are being followed and no one is selling/serving items not allowed with the new policy 711. He thanked us as a H&S and PSSC, as well as our Principal Jo-Ann for following the rules and changing our fundraiser to keep in accordance to the policy. He wanted to contact us and let us know he was doing his best to shut down these events/fundraisers and contacting school principals and administrators to remind them of the policy. If there were any more questions or concerns that we are free to reach out at anytime to him.
