SCHOOL SUSTAINABILITY REVIEW and SCHEDULE OF PUBLIC CONSULTATIONS

The Anglophone South District Education Council (DEC) will host Public Consultations as per Provincial Policy 409 *Multi-Year School Infrastructure Planning* to study the sustainability of **Morna Heights School.**

Under Policy 409, the DEC will be holding two public information sessions at the school. The initial meeting will be to deliver the proposal to the public and to allow the DEC and staff to explain the process involved in a Policy 409 review and be available to answer questions about the process.

A second meeting will be scheduled in November to allow the public an opportunity to ask questions about the proposal, voice their concerns and provide feedback to the review.

The first meeting for Morna Heights School is scheduled for Thursday, October 10 at 6:30 pm at Morna Heights School.

Policy 409 – Section 6.5 Determining a School's Sustainability

6.5.1 A DEC must consider the following criteria when studying a school's sustainability. This list does not preclude a DEC from considering other factors relevant to their local circumstances.

Policy 409 – Section 6.6 Public Consultation on School's Sustainability

- ▶ 6.6 Public consultation on a school's sustainability
- 6.6.1 Following a public meeting at which the DEC has indicated its intention to conduct a sustainability study, the DEC must hold a minimum of three public meetings as part of a school sustainability study.
- 6.6.2 The first meeting will inform the school community of the DEC's intention, the criteria and factors to be considered and the steps to be followed. The DEC must ensure that affected persons are provided with information relevant to the proposal.

Policy 409 – Section 6.6 Public Consultation on School's Sustainability (continued)

- 6.6.3 The second meeting will provide affected persons with the opportunity to make a presentation to the DEC (i.e., let their views be known either in writing or orally). The DEC must provide them with adequate time to express their views and ensure they are heard impartially. The DEC must also ensure that affected persons have adequate time to prepare and consider the information received during the first meeting.
- 6.6.4 The **final meeting** will provide the public with the results of the consultation and the resulting recommendations being submitted to the Minister, as per section 6.7.

Policy 409 – Section 6.7 Ministerial Approval of a School Closure


- 6.7.1 A DEC will inform the Minister in writing of a recommendation to close a school, following the public consultation process. The DEC must provide supporting documents that demonstrate to the Minister how the requirements of this policy have been applied.
- 6.7.2 Any DEC recommendation to close a school as a result of a sustainability study must be submitted to the Minister no later than January 31, if the DEC intends for the school to close during the current school year. An extension of this timeline may be granted to the DEC with approval of the Minister.



Morna Heights Elementary - Background

- K-5 Elementary school built in 1963
- Max capacity for Morna Heights is 145 students
- Has 6 classrooms, 2 modulars are used for Library and Music
- Modulars were not new when placed at school 22 years old
- 69 students enrolled as of Sept. 2018
- Morna Heights is at 48% capacity as of Sept. 2018
- Enrolment has declined by 49% since 2004 (65 students)
- For French Immersion, if room, students go to Grand Bay Primary then Inglewood, if not to Westfield Elementary
- Morna Heights students go to River Valley for Middle & Saint John area for High School
- Morna Heights has a gym, playground, basketball court, sufficient green space and parking space
- Morna Heights is not wheelchair accessible
- Morna Heights has ongoing Health & Safety issues including air and water quality (no central ventilation and on potable water)



Multi-year Infrastructure Planning:

- DEC requested update of proposal for the Grand Bay –
 Westfield and Morna area that was studied in 2015/16
- Proposal was to close Grand Bay Primary, Inglewood and Morna and build new K-5 School
- Project was on the list 2008/09 then updated in 2015/16
- Project did not garner any interest at Dept. level so it was moved to 3rd on Capital Construction list in 2019
- Morna's population has dropped 33% since last study
- New proposal is to close Morna, review school boundaries and move students to Saint Rose (K-5 Eng.)
- Grade 6 & 7 students in River Valley will be grandfathered
- Saint Rose has excess capacity 205 students (Sept. 2018) @ 43% capacity
 - Distance from Morna Heights to Saint Rose is 9.2 kms

Morna Heights - Transportation

- Two busses currently serve Morna, 2 AM routes and 2 PM routes
- Have 18 walkers, 6 out of zone, & 46 on buses
- Average distance to Morna Heights for bussed students is around 4 kms
- Max. bussing distance to Morna is 7 kms
- Bussing to Saint Rose will add average of 5 kms, max. of 9 kms to the bus runs, depending on the students' home address
- All Morna area students would be entitled to bussing to Saint Rose



Saint Rose Elementary - Background

- K-5 Elementary school built in 1960
- School is owned by the Diocese
- Max capacity for Saint Rose is 483 students
- 205 students enrolled as of Sept. 2018
- Saint Rose is at 43% capacity as of Sept. 2018
- For French Immersion, students would go to Island View
- Students would go to Barnhill for Middle & Saint John area for High School
- Saint Rose has a gym, playground, basketball court, sufficient green space and parking space and is located near a ballfield and soccer field
- Saint Rose is wheelchair accessible and has a lift
- Saint Rose has no ongoing Health & Safety issues
- Saint Rose has an afterschool program located inside the school

Saint Rose Elementary – School Programs and Clubs

Saint Rose Elementary – School & Community Involvement

- Trips organized by the Parent Involvement Committee (apple picking, Pink Bus tours, sugar bush etc. depending on the year)

Summary of Factors that Determine a School's Sustainability:

- Low/declining enrolment: Morna Heights enrolment has dropped by 49% since 2004, 68 students.
- ➤ Health and Safety: There have been on-going air quality concerns (i.e. smell in gym) and there is no central ventilation system in the school. Potable water is provided to the school as the well water continues to fail the monthly bacteria test.
- Quality of Education Programs: Both schools offer strong education programs. Our experience has been that community partners will follow students when schools are closed.
- Transportation: The boundaries of both schools border on each other and can be combined for transportation purposes.

Summary of Factors that Determine a School's Sustainability:

- Impact on local community: The enrolment at Morna Heights has continued to decline to the point where nearby schools can absorb the population of the school. Morna is located within the City of Saint John boundary as is Saint Rose Elementary.
- ► Impact on other schools: Morna Heights would be closed and the students moved to Saint Rose Elementary for K-5 and then Barnhill Middle for 6-8. River Valley Middle would see a decrease in their future enrolment because of this change.
- Economic development: No impact noted.
