

Information Bulletin for Parents and Guardians English Language Proficiency Assessment / Reassessment Grades 9, 11, and 12

The English Language Proficiency Assessment/Reassessment (ELPA/R) is an assessment of students' reading skills based on the Atlantic Canada English Language Arts Curriculum Outcomes (Grade 8) and the New Brunswick Provincial Achievement Standards in Reading (end of Grade 8).

Data obtained from the ELPA/R provide information about individual student achievement in literacy and offer a perspective on school, district and provincial trends.

Who participates in the English Language Proficiency Assessment (ELPA)?

The ELPA is compulsory for all students in **Grade 9**, unless an exemption is obtained. It is a High School Graduation Requirement and students must attain a minimum score of Appropriate Achievement to meet this requirement.

Who participates in the English Language Proficiency Reassessment (ELPR)?

The ELPR is identical to the ELPA and is written by students in **Grades 11 and 12** who have not yet attained a minimum score of Appropriate Achievement or who obtained an exemption. Students in **Grade 10** who were unsuccessful on the ELPA **do not participate** in the assessment during their Grade 10 year. This allows them to receive targeted literacy intervention before they write the ELPR in Grade 11.

Are accommodations available?

Accommodations are alterations that do not jeopardize the integrity or content of the assessment. Such accommodations give students an equal opportunity to demonstrate what they know and can do. Not all accommodations available in the classroom setting are appropriate for provincial assessments. Requests for accommodations require the approval of the school principal, district, and EECD. Who may be exempt?

Any student may be exempt from participating in the ELPA/R if justified by the student's Personalized Learning Plan (PLP). Approval of parents/guardians, school principal, district, and EECD is required. A permanent or temporary exemption may be requested.

When do students write the ELPA/R?

The ELPA/R is written during the high school exam period, January 14-25, 2019.

What is the format of the ELPA/R?

To ensure that it is fully aligned with our provincial standards, a review committee of New Brunswick educators selected the content of the assessment. Students will have 90 minutes to complete the assessment with up to 90 extra minutes, if needed.

The use of dictionaries, thesauri and translation devices is **not** permitted for the ELPA/R.

Content:

Literal Responses	20%
Inferential/Interpretive Responses	60%
Personal/Critical/Evaluative Responses	20%

How will the results be reported?

The ELPA/R results will be reported as Strong Achievement (SA), Appropriate Achievement (AA), or Below Appropriate Achievement (BAA) and by percentage of questions correct for each genre (literary and informational) and question type (literal, inferential/interpretive, and personal/critical/evaluative).

Students receive their own results.
