- 1. Principal's Report:
  - a. Report on status of renovations to bathrooms request: facilities has approved the renovation of the single bathroom so that it can be used as a "universal" washroom. In the other bathrooms, approval has been granted by facilities to build stalls but

the details of what this will look like remain uncertain. The plans still need final approval by finance.

- b. No word vet on FTE/staffing for next year.
- c. Information regarding Pertussis was sent home in response to an identified case in the school. The child diagnosed with pertussis is no longer contagious but parents are encouraged to read the information provided as a precaution.

#### 2. DEC Report:

- a. A new DEC Policy is being considered that relates to Gender Identity. DEC's from other jurisdictions around the province have implemented similar policies in the last couple of years.
- b. Last meeting on the sustainability study for Kingsclear Consolidated School is scheduled for May 4<sup>th</sup>.
- c. Carlton North naming has been approved by the naming committee.
- d. Code of Conduct misrepresentation investigation is ongoing however it has been determined that procedures were correctly followed.
- e. DEC approved a land trade deal for John Caldwell School with the Town of Grand Falls that will allow for the newly traded land to be used as a school playground as well as for the development of a new community park.
