MSN statement: Give a couple of minutes for all to read.

*Para 1: Because this is a positive learning environment, the staff of the Burton School knows the strength and weakness of every student and tailors different teaching techniques to each student, ensuring to correctly developing and preparing our future.

Slide 4:

*Para 2: With the close knit environment of the Burton School, all staff knows and enhances all the potential of all students as every one knows everyone. Miss Appleyard knows all the Grade 2 students, Mrs Doucet knows all the kindergarten students and Miss Nadeau knows the reading level of each student in the school through the library. The Burton School achieves the aim.

Slide 5:

*Para 3: Not a community, but THE community, THIS community, Burton. This is the future. The first introduction to the educational system must be an enriched, positive working environment and develop the required skills so our children can be functional members in society. The Burton school meets these criteria and goes beyond due to the positive atmosphere our children can began to develop all the required life skills. In a small community and school it only enhances the learning ability due to the closeness of the staff, student, parent and community relationship. It's almost like the circle of life.

Slide 6: Statistics (reading)

Provincially, only grade 2 is tested, at the Burton School, our grades 2 are tested then they are moved to another learning institute and the statistics are then reflected elsewhere. We need to keep it here at the Burton School.

The learning at the Burton school is second to none; it's just below district and Provincial standards, however due to only one grade 2 class at the Burton School, if 2 students due poorly on the exam, the percentage is not a true reflection of the education received as if 2 students in larger schools did poorly.

Slide 8: School Boundaries: (read first two points first)

Currently the school boundaries for the Burton school do not in any way reflect the area of Burton. For some reason only portions of Burton residence attends Burton where others that live in Burton are bussed to other learning institutes outside the walls of our community.

Slide 10: CIP:

CIP is a sum of monies the District receives annually to upkeep all its school within its jurisdiction. Roughly the District receives 1 million a year for this project. The District then prioritizes the projects that need repair.

At first glance it looks impressive for the amount of money that was spent on Burton. However if we break it down, in the last 11 years \$103 114 was spent on the Burton School out of a possibility of 11 million. Not a lot of love and care has been shown to the school. If you look from 2004 - 2010 it shows 6 yrs of neglect. It's almost like someone was situating the estimate for the closure of the Burton School. And now a review is being conducted on all CIP for the Burton School due to over inflation.

Finances were the districts selling feature to issue POLICY 409 on the Burton School, as stated numerous times in the media. The District stated in the media it

will cost over 700,000 to repair the school, now its numbers are under a review due to over inflation.

How can you make an honest judgment knowing that the information is false.

Slide 11: Major Capital Project.

This is a totally different budget then CIP. This is for the construction of a new school, like let's say.... Lincoln for example, or the renovations of an existing school, like Geary is trying.

Since the Burton School is being neglected and is not receiving any of the monies awarded through CIP, the District should use the Major Capital Project budget to improve our children's leaning facility here at the Burton School

Slide 12: Enrollment.

Burton is a mixed Military and civi community. Population growth is on the rise in this community as evident by the housing constructions, constructions of new roads. It is a growing community.

Slide 13: Enrollment.

Currently 111 little Burtonites are being shipped outside our community of Burton to other education institutes in other communities.

We need to set the community and school up for success.

Increase the Burton boundaries of the school to reflect the actual Burton limits on the ground;

Increase the school to K-5 through the Major Capital projects, just like Lincoln did. The amount of students that would attend Burton School would match Lincoln, Geary or Gagetown.






